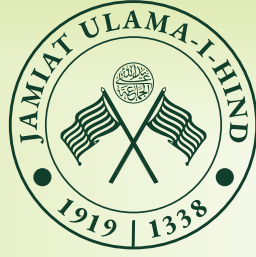

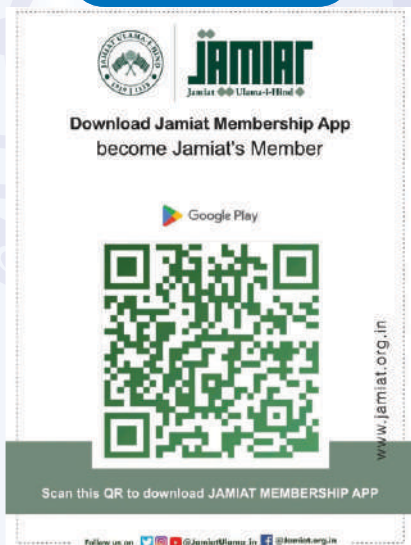
# Jamiat President Launches New Membership App

New Delhi, 11 February 2025:

Jamiat Ulama-i-Hind President, Maulana Mahmood Madani, today launched a new app-based membership system at the organization's headquarters in Madani Hall, New Delhi, to enhance organizational efficiency and effectiveness. The app, available on the Play Store under the name JUH-Membership-Drive, has been introduced for the 2024-27 membership term to make the registration process more accessible, streamlined, and transparent.

The launch event was attended by Jamiat Ulama-i-Hind's General Secretary, Maulana Muhammad Hakeemuddin Qasmi, and Secretary, Maulana Niaz Ahmed Farooqi, Advocate, among others.

Addressing the gathering, Maulana Mahmood Madani emphasized that a strong organizational structure is crucial for any community, whether in the majority or minority. He stated that an organization's primary goal is not just to protect its identity but also to shape the future and implement its vision effectively. He reaffirmed Jamiat Ulama-i-Hind's renewed determination and commitment in the face of current challenges. Maulana Madani highlighted that history has always favored well-organized communities that work systematically to achieve their objectives. He stressed that while challenges persist, wisdom, long-term planning, and relentless efforts can help overcome them.



Responding to a media query, Maulana Madani asserted that upholding the Indian Constitution and ensuring equal rights for all communities is the duty of every citizen. He categorically rejected any form of domination by a particular community, emphasizing that justice and equality are the true essence of democracy.

He further remarked that apprehensions and expectations are a natural part of life but should not deter people from their path. He reiterated, "We have consciously chosen this country as our homeland—it is not a mistake or an accident. We expect equal treatment from both central and state governments, ensuring justice, equality, dignity, and protection of identity without promoting the superiority of any one community. We will not tolerate any violation of the Constitution, and its protection must be ensured at all costs."

Maulana Madani emphasized that Jamiat Ulama-i-Hind is not just an organization of ulama but

Explaining the new membership system, Maulana Madani stated that while the traditional method remains intact, modern technology has been integrated to enhance efficiency. The online system was introduced in the previous term as well but has now been further refined and improved.

Presenting data, he noted that in the last term, Jamiat Ulama-i-Hind had 6,800 local units, compared to only 1,700 units two decades ago. Membership has also seen a significant rise from 1.5 million to over 11 million. For the current term, the organization aims to establish at least 11,000 active local units, with a focus on education, social welfare, and training initiatives rather than merely increasing numbers.

## Massive Crowd at Membership Drive Camp in Muzaffarnagar

Muzaffarnagar, Uttar Pradesh, 26 February 2025:

Under the leadership of Maulana Mahmood Asad Madani, President of Jamiat Ulama-i-Hind, a membership drive camp was organized on February 25 in the Muzaffarnagar district of Uttar Pradesh, where hundreds of people were enrolled as members of Jamiat Ulama-i-Hind.

## Strongly Condemns US President's Statement on Gaza

New Delhi, 6 February 2025:

**M**aulana Mahmood Madani, President of Jamiat Ulama-i-Hind, has strongly condemned the statement made by US President Donald Trump, in which he proposed the American occupation of Gaza and the forcible displacement of the Palestinian people. Maulana Madani described this proposal as not only absurd but also a direct violation of international law and human rights.

Maulana Madani emphasized that Gaza is not just a piece of land; it is the home of millions of Palestinian people who have suffered for decades under occupation, aggression, and injustice. Any

attempt to forcibly expel the Palestinian people from their homes would constitute a grave assault on human dignity and rights.

He further highlighted that nearly 50,000 innocent lives have already been lost in the recent Israeli aggression, and any further unjust plans would only add insult to injury, exacerbating the suffering of the Palestinian people. Maulana Madani expressed deep dismay that the US President, alongside a ruthless Israeli leader, is endorsing such a draconian proposal from the White House. He stated that any leader with a conscience would be ashamed to support a plan so callous and inhumane.

Jamiat Ulama-i-Hind calls on the international community, especially the United Nations and influential global powers, to reject this plan outright and take immediate, practical steps to ensure the restoration of the legitimate rights of the Palestinian people. India has consistently taken a principled stand in support of Palestine, and it is crucial that the country remain steadfast in upholding this position and continue to speak out for justice and peace.

Jamiat Ulama-i-Hind reaffirms its unwavering solidarity with the Palestinian people and demands the rebuilding of Gaza, the restoration of Palestinian rights, and the pursuit of a just and lasting resolution to the Palestinian issue.



# Jamiat Delegation Visits Demolished Madani Mosque in Hata, Kushinagar

New Delhi, 19 February 2025:

A delegation led by Maulana Hakimuddin Qasmi, General Secretary of Jamiat Ulama-i-Hind, visited the Madani Mosque in Hata, Kushinagar, which was recently demolished as part of an administrative action. The delegation engaged in detailed discussions with Haji Shakir and other mosque representatives, assessing the current situation, the reasons behind the demolition, and its broader implications. They urged the community to remain patient and steadfast, emphasizing the importance of seeking justice through legal and constitutional means with complete faith in Allah.

Maulana Hakimuddin Qasmi reaffirmed that Jamiat Ulama-i-Hind is taking this matter with utmost seriousness and will pursue all possible legal avenues. He recalled that under the leadership of Jamiat President Maulana Mahmood Asad Madani, a prolonged legal battle was fought in the Supreme Court last year against bulldozer actions, resulting in a directive to halt illegal demolitions. Given this context, the demolition of the Madani Mosque is not merely the destruction of



a place of worship but an affront to justice, the rule of law, and judicial integrity. The matter is now before the Supreme Court once again, and Jamiat remains hopeful for a just resolution.

The General Secretary reassured the local community that Jamiat Ulama-i-Hind stands firmly with them in their struggle. He reiterated that the organization has always been a voice for the oppressed and remains committed to defending their rights.

## *Five Minors Among Seven Innocent Individuals Acquitted in Mewat Violence Case*

New Delhi, 15 February 2025:

**Dr. Priyank Jain**, Principal Magistrate of the Juvenile Justice Board, Nuh, has acquitted five minors of all charges. Additionally, the Nuh Sessions Court has dismissed cases against two adults, Mohammad Majlis (Jai Singhpur) and Mehboob (Jai Singhpur).

The prosecution (State Government) presented a weak case, as no CCTV footage provided evidence of the accused's involvement. Furthermore, there was no call location or CDR record to establish the presence of the minors at the crime scene, nor was any incriminating material recovered from them. The accused were neither arrested from the site of the incident nor apprehended at the time of the event. Moreover, witnesses failed to identify the children during cross-examination.

In light of these facts, the court found no substantial evidence linking the minors to the case, leading to their acquittal and the release of their bail bonds. The Probation Officer of Nuh has been instructed to prepare an Individual Care Plan for the minors as per the provisions of the law. Additionally,

the case records will be maintained under Section 24(2) of the Juvenile Justice Act 2015 and Rule 14 of the Juvenile Justice Rules 2016. After completing the necessary formalities, the case file will be sent to the record room.

Advocate Tahir Rupadia and his legal team represented the innocent individuals on behalf of Jamiat Ulama-i-Hind. The families of the acquitted individuals expressed their heartfelt gratitude to Jamiat Ulama-i-Hind.

It is worth mentioning that following the violence in Nuh, Mewat, on July 31, 2023, hundreds of people were arrested, most of whom were innocent. Seeking justice, their families approached Jamiat Ulama-i-Hind's General Secretary, Maulana Hakimuddin Qasmi, requesting legal assistance. After consultations with local Jamiat representatives, legal aid was initiated.

Under the supervision of Jamiat Ulama-i-Hind's Secretary and Supreme Court Advocate Maulana Niaz Ahmed Farooqui, a dedicated team of lawyers was formed, including Advocate Tahir Rupadia, Advocate Haroon, and their team, to handle the cases. Jamiat Ulama-i-Hind is currently pursuing 663 cases related to the Nuh violence, securing bail in 645 of them.

Stability comes only when justice prevails."

During their visit, the Jamiat delegation also toured Sambhal's historic Jama Masjid, meeting with local leaders and community representatives to discuss the ongoing situation and explore further avenues of support and advocacy.



## Supreme Court Hearing on Places of Worship Act: Government Yet to File Its Response

New Delhi, 17 February 2025:

The Supreme Court today (February 17) deferred the hearing of the pleas concerning the Places of Worship Act, 1991, to April. A bench comprising Chief Justice of India (CJI) Sanjiv Khanna and Justice Sanjay Kumar directed that the matter be listed for hearing in the week commencing April 1. Notably, the case was previously heard by a three-judge bench consisting of CJI Sanjiv Khanna, Justice Sanjay Kumar, and Justice KV Viswanathan.

The Supreme Court is simultaneously examining petitions challenging the constitutional validity of the Act and petitions from Jamiat Ulama-e-Hind President Maulana Mahmood Asad Madani and others, who are demanding the strict enforcement of the Act. Since today's hearing was before a two-judge bench, the matter was adjourned.

Representing Jamiat, Advocates Mansoor Ali Khan and Niaz Ahmed Faruqi appeared before the Court. The Jamiat lawyers raised concerns over the government's continued silence and failure to submit its reply, urging that the Government should promptly file its response considering the nation's integrity, the sensitivity of the issue, and the need to uphold the law.

The Union Government has yet to file its counter-affidavit, despite

being granted multiple extensions by the Supreme Court. On July 11, 2023, the Court directed the Union Government to file the counter by October 31, 2023, but it has failed to do so. Notably, on December 12, 2023, a bench comprising CJI Sanjiv Khanna, Justice PV Sanjay Kumar, and Justice KV Viswanathan passed a significant order halting fresh suits and survey orders against religious places. The Court further directed that in pending cases (such as those concerning Gyanvapi Mosque, Mathura Shahi Idgah, and Sambhal Jama Masjid), the lower courts should not issue any effective interim or final orders, including orders for surveys.

The interim order was issued while hearing a batch of petitions challenging the Places of Worship (Special Provisions) Act, 1991, alongside a petition seeking its implementation.

## ***Birth Certificate is the Strongest Proof of Citizenship; Citizens Must Prioritize It: Maulana Nadeem Siddiqui***

*Mumbai, 20 February 2025:*

**A** birth certificate is the strongest proof of citizenship, and citizens who do not have one must register for it before April 27, 2026. The government has made it clear that no further extensions will be granted beyond this deadline. Moreover, the Registration of Births and Deaths (Amendment) Act, 2023, has been in effect nationwide since October 1, 2023, making the birth certificate a mandatory document for various official purposes.

These remarks were made by Maulana Hafiz Mohammad Nadeem Siddiqui, President of Jamiat Ulama Maharashtra, in a press statement. He emphasized that while many people assume that the date of birth mentioned in school certificates is sufficient proof, it is not always legally reliable. Therefore, citizens must obtain an authentic birth certificate as soon as possible.

## ***Jamiat Organizes Two-Day Training Workshop for Senior Fellows***



*New Delhi, 11 February 2025:*

**U**nder the guidance of Jamiat Ulama-i-Hind President Maulana Mahmood Asad Madani, a two-day training workshop and a special session for senior fellows (organizers) were held at the central office in Delhi on February 10-11, 2025. The workshop was attended by 20 senior fellows from across the country.

Distinguished ulama, including Maulana Mahmood Asad Madani and Jamiat General Secretary Maulana Hakeemuddin Qasmi, delivered insightful addresses emphasizing organizational unity, professional excellence, and social responsibility. Special guest Maulana Saeed Ahmad from the UK also shared valuable perspectives on current affairs and the contributions of past leaders.

The workshop featured expert-led sessions addressing field challenges, membership drives, financial planning, and organizational growth. ## Jamiat President Urges Focus on Girls Education

New Delhi, 20 February 2025:

The Khatm-e-Bukhari Sharif and certificate distribution ceremony was held at Jamiat Aisha Al-Siddiqah Lilbanat, an educational institution for girls under Jamia Al-Hidayah, in Jamia Nagar, Nagla Raai, Muzaffarnagar district, West UP. A total of 45 students successfully completed their Alimah and Fazilah courses alongside their high school education, receiving certificates and honors. Thousands of people from the region and surrounding areas attended the event, where the graduating students were conferred honorary titles and Dastar-e-Fazilat (turbans of distinction) in recognition of their achievements.

The event was presided over by Maulana Mahmood Madani, President of Jamiat Ulama-i-Hind. The special guest for the occasion was Mufti Mohammad Salman Mansoorpuri, Naib Ameer-ul-Hind and Hadith scholar at Darul Uloom Deoband. The program was jointly hosted by Maulana Musa Qasmi, Maulana Mohammad Ehsanul Haq Qasmi, and Maulana Suhail Akhtar Rahimi, administrators of Jamia Al-Hidayah.

In his keynote address, Maulana Mahmood Asad Madani emphasized that knowledge is an endless pursuit. He stated, "A mother's lap is the first school for a child. Educated women not only uplift themselves but also benefit future generations. Therefore, alongside boys, it is imperative to give special attention to the education of girls." He further stressed that providing

both religious and contemporary education is a collective responsibility.

Maulana Madani also highlighted the continued injustices against women, drawing parallels between the past and present. He said, "During the era of ignorance, girls were buried alive after birth. Today, the situation is no different—many are denied their right to life through gender-based abortions. Violence and injustices against women are increasing, which is deeply concerning. Even the inheritance rights granted to daughters under Islamic law are often not fulfilled."

Delivering the concluding lesson on the final Hadith of Sahih Bukhari, Mufti Mohammad Salman Mansoorpuri spoke about the scholarly contributions of Imam Bukhari (RA) and the excellence of his compilation. He stated, "Sahih Bukhari is unanimously regarded as the most authentic book after the Holy Quran."

In his address, Hafiz Mohammad Furqan Asadi, President of Jamia, urged the audience to adhere to the teachings of Prophet Muhammad (PBUH) in their daily lives. He emphasized, "Those who live their lives according to the Sunnah of the Prophet (PBUH) will be beloved to Allah."

Maulana Mohammad Ehsanul Haq Qasmi, Director General of Jamiat Aisha Al-Siddiqah Lilbanat, presented a report on the institution's academic progress and outlined future aspirations. **Jamiat Ulama Telangana Demands Investigation into Sangareddy Incident**

**Hyderabad, 18 February 2025:**

**A** delegation from Jamiat Ulama District Sangareddy visited Mohammed Ismail, a resident of Antaram village, Manpally Mandal, Sangareddy district, to inquire about a distressing incident involving his family.

Speaking to the media, the delegation detailed the events of February 11, when Mohammed Ismail went to relieve himself near a drain close to his house. This led to an objection from his neighbors, Veera Reddy and Vijay Reddy, sparking an argument that escalated into a violent altercation, despite a distance of nearly 70 meters between their houses.

According to the delegation, Vijay Reddy and Veera Reddy, along with their supporters, allegedly launched a brutal attack on Ismail. During the assault, his 15-year-old daughter, Alia Begum, a 10th-grade student,



intervened to save her father. The attackers then turned on Alia Begum, striking her with a heavy stone, causing severe injuries. She was rushed to a nearby hospital but succumbed to her injuries on February 15 while undergoing treatment at a hospital in Sangareddy.

Jamiat Ulama Sangareddy leaders visited the grieving family to express their condolences and assured them of full support. Speaking to the media, Jamiat representatives

strongly condemned the premeditated attack and demanded that all those involved be brought to justice.

Hafiz Peer Khaleeq Ahmed Sabir, General Secretary of Jamiat Ulama Telangana, has spoken to the Chief Minister's Secretary and the District Superintendent of Police, urging an impartial investigation into the incident. He further accused the police and medical authorities of fabricating a false report against the victim and demanded that the case be investigated under the supervision of a sitting judge to uncover the truth.





## *Two-Day Workshop on Hate Crimes and Islamophobia Successfully Concludes*



New Delhi, 21 February 2025:

A two-day workshop on Hate Crimes and Islamophobia, organized by the Jamiat Ulama-i-Hind's JEM (Justice & Empowerment of Minorities) department, was successfully held on February 20-21, 2025. The workshop saw participation from youth, social activists, lawyers, and researchers from across the country. The primary objective of the workshop was to address the rising trends of hate crimes, understand Islamophobia, and develop effective legal and social strategies to counter these challenges.

The workshop was inaugurated with an address by Maulana Mahmood Asad Madani, President of Jamiat Ulama-i-Hind, who highlighted the organization's continuous efforts in protecting constitutional rights and promoting national harmony. He emphasized the urgent need to combat hate and communalism through intellectual, academic, and legal means to ensure justice and social cohesion.

The workshop featured insightful sessions from prominent intellectuals, journalists, and legal experts, including:

- Aditya Menon, a renowned political analyst, provided a detailed analysis of the evolution of hate crimes and communalism in India, explaining how political and social factors contribute to their rise.
- Advocate Abu Bakar Sabaq spoke on legal recourse against hate crimes and Islamophobia, stressing the importance of legal awareness so that young individuals can effectively safeguard their constitutional rights.

- Saurabh Vajpayee, a historian, shed light on the role of Indian Muslims in nation-building and debunked distorted historical narratives. He explained how the misrepresentation of Muslim history fuels social divisions.
- Abhishek Srivastava, author and journalist, discussed perception-driven narratives and their influence on national issues, highlighting the need to counter divisive rhetoric in society.
- Maulana Azeemullah Siddiqui elaborated on the vision of Jamiat Ulama-i-Hind, explaining how the organization has been committed to social justice, peace, and constitutional rights since its inception.
- Mufti Syed Muhammad Afan Mansoorpuri delivered an enlightening talk on human rights in Islam, emphasizing that Islamic teachings uphold human dignity, justice, and equality, leaving no room for hatred or discrimination.

### *Training and Practical Sessions*

The workshop also included interactive training sessions, conducted under the supervision of Abdul Mumin, in charge of JEM, and Ovais Sultan Khan, coordinator of Jamiat India Chapter 1. Participants received training in:

- ✓ **Identifying and categorizing hate crimes.**
- ✓ **Understanding legal provisions and filing complaints.**
- ✓ **Detecting misinformation and fake narratives in mainstream and social media.**
- ✓ **Fact-checking and developing counter-narratives.**
- ✓ **Strategies for community engagement and youth empowerment.**

In the closing session, Maulana Niaz Ahmad Farooqi, Secretary of Jamiat Ulama-i-Hind, urged participants to continue their pursuit of knowledge and legal awareness. He emphasized that the youth must actively participate in raising awareness about hate crimes and social injustices.

To ensure sustained engagement, WhatsApp groups were created at the state level to facilitate better communication among participants and provide regular training materials and guidance.

This workshop marks another step in Jamiat Ulama-i-Hind's ongoing efforts to foster a just, inclusive, and harmonious society.





## Religious Significance of Jamiat Ulama-i-Hind

Some people believe that Jamiat Ulama-i-Hind is merely an organization founded by Sheikh-ul-Hind Maulana Mahmood Hasan (RA), Sheikh-ul-Islam Maulana Hussain Ahmed Madani (RA), Mufti Azam Maulana Mufti Kifayatullah (RA), and Sahbanul Hind Maulana Ahmad Saeed Dehlvi (RA), and that it exists solely due to the personal greatness and piety of these revered elders. They assume that the objectives and methodology of the organization should neither be questioned nor discussed. However, defining Jamiat Ulama-i-Hind solely based on its esteemed founders reflects a limited understanding of its mission.

It is, therefore, the responsibility of Jamiat workers to possess an accurate understanding of the organization's objectives and methodology. Their affiliation should be based on conscious awareness rather than mere belief.

We must recognize that Jamiat Ulama-i-Hind is not solely dependent on the personal greatness of its leaders but has a clear mission, a well-defined policy, and a structured approach, all of which are rooted in the divine guidance of Islam. Its methodology is derived from the Sunnah of Prophet Muhammad (PBUH). Many individuals fail to engage wholeheartedly in Jamiat's constructive work because their association is driven by social obligation rather than genuine conviction.

If we sincerely internalize the objectives of Jamiat

Ulama-i-Hind, we will realize that every moment spent in the service of religion and the nation is rewarded by Allah with His divine pleasure. In simple terms, Jamiat Ulama-i-Hind aims to establish the Prophetic model and ensure that divine guidance governs all aspects of life. ### A Brief Overview of Jamiat Ulama-i-Hind's Contributions Before Independence

During the 28 years preceding independence, Jamiat Ulama-i-Hind played a crucial role in India's freedom struggle, making tremendous sacrifices. Thousands of its members laid down their lives for the cause of freedom. At the same time, Jamiat stood as the guardian of Islamic identity and Shariah, ensuring that Indian Muslims remained steadfast in their faith amidst colonial oppression.

Jamiat not only worked alongside Mahatma Gandhi in the struggle for independence but also fought tirelessly to safeguard the religious, cultural, and national rights of Indian Muslims on all fronts.

To counter forced conversions and apostasy, Jamiat launched awareness campaigns in different periods. It successfully rescued thousands of Muslims from coercion and helped them revert to their faith. Moreover, Jamiat consistently emphasized unity among Muslims and solidarity with Muslim nations worldwide.



## Post-Independence Services

The independence of 1947 brought both joy and tragedy for Indian Muslims. The Partition placed them in an extremely difficult situation—while some migrated to Pakistan, those who remained in India faced suspicion, alienation, and discrimination.

At this critical juncture, Jamiat Ulama-i-Hind's prominent leaders travelled across the country, urging Muslims not to leave their homeland. They encouraged and reassured the community, providing them with the strength to remain firm in their faith and identity.

Had it not been for the tireless efforts and midnight prayers of these elders, the presence of over 200 million Muslims in India today might not have been possible.

After Partition, Muslims faced another major crisis due to the Evacuee Property Law (commonly known as the Custodian Law), which deprived thousands of Muslims of their properties. Jamiat Ulama-i-Hind's leader, Maulana Mohammad Hifzur Rahman (RA), took a stand against this injustice, compelling the authorities to revise the law. As a result, the Tribunal System was introduced, enabling rightful claimants to reclaim their properties.

## Jamiat's Key Contributions

**Jamiat has continuously worked for:**

- ✓ The preservation of Islamic identity.
- ✓ The protection of Muslim Personal Law.
- ✓ Support for Islamic madrasas.
- ✓ The safeguarding of Waqf properties.

Additionally, Jamiat's humanitarian efforts have been remarkable, including disaster relief, riot rehabilitation, and legal aid. Some key interventions include:

- ⇒ Relief efforts following the 2001 Gujarat earthquake.
- ⇒ Rehabilitation of victims from the 2002 Gujarat riots, 2012 Assam-Bodo riots, and 2013 Muzaffarnagar riots.
- ⇒ Legal aid for victims of the 2020 Delhi riots and the 2023 Mewat violence.
- ⇒ Defending innocent Muslim youth falsely accused of terrorism-related charges.

### Religious and Worldly Benefits of Becoming a Member of Jamiat Ulama-i-Hind

#### (1) Allah's Command Regarding the Establishment of Jamaat

Allah commands in the Quran: "Let there be a group among you who call [others] to goodness,

"I command you with five things that Allah has commanded me: to remain with the Jamaat, to listen and obey, to migrate, and to strive in the path of Allah. Whoever distances himself from the community even by a handspan has cast off the bond of Islam from his neck until he returns. And whoever calls to ignorance is among the inhabitants of Hell." (Musnad Ahmad, Hadith No. 17302)

#### (3) Allah's Support is with the Community

**The Prophet (peace be upon him) said:**

"It is essential for you to remain with the Jamaat." (Sunan al-Tirmidhi) "Allah's hand is with the community." (Sunan al-Tirmidhi) This hadith is engraved on Jamiat Ulama-i-Hind's emblem.

#### (4) Becoming a Member is an Act of Righteousness and Cooperation in Good things

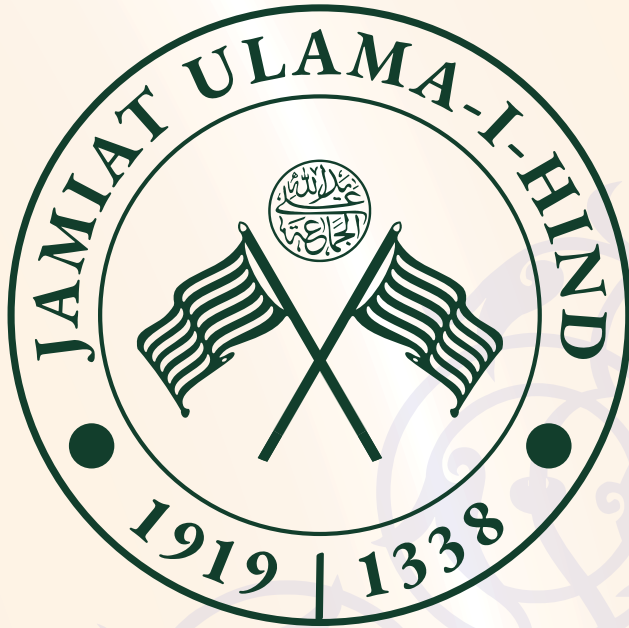
"Cooperate in righteousness and piety, but do not cooperate in sin and transgression. And fear Allah; indeed, Allah is severe in punishment." (Surah Al-Ma'idah 2)

A religious benefit of being affiliated with Jamiat Ulama-i-Hind is that if any member performs a righteous act, its reward is shared by other members because they are collectively supporting this noble cause.

#### (5) The Constitution and Mission of Jamiat Ulama-i-Hind is the Solution to All Challenges Faced by Indian Muslims

The principles of Jamiat Ulama-i-Hind are based on the Quran, Hadith, and the practices of righteous predecessors from the Ahl-e-Sunnah wal Jama'ah. Therefore, Indian Muslims, particularly in Punjab, are





urged to join Jamiat in large numbers and actively implement its system.

Serving humanity is as much an act of worship as prayers and fasting, and according to some Hadiths, it is even superior to nafl ibadat. Jamiat Ulama-i-Hind provides an excellent platform for fulfilling this important religious duty.

### **(7) Becoming an Indispensable Part of Society**

Affiliation with an organization like Jamiat should be driven by consciousness and religious commitment rather than worldly gain.

When the idolaters of Makkah oppressed Abu Bakr (RA) and he intended to migrate, Ibn al-Daghinah stopped him, saying:

"A person like you should neither leave nor be expelled, because you maintain family ties, support the weak, host guests, and assist people in distress."

These were the same qualities that Hazrat Khadijah (RA) had attributed to the Prophet (peace be upon him). Jamiat Ulama-i-Hind embodies these very values, making its members invaluable to society.

If we become indispensable to our country and beneficial to its people, we will be firmly established, for Allah states:

"That which benefits people remains on the earth."

(Surah Ar-Ra'd 17)

### **(8) Collective Decisions Hold Greater Significance than Individual Opinions**

During British rule, despite numerous individual petitions to governors, viceroys, and even the House of Commons regarding their injustice, no action was taken. Eventually, when influential figures complained to the Viceroy of India, he responded:

"Your actions are individual efforts. You should form an organization and present your demands collectively. The British government values collective demands."
