

## Jamiat Ulama-i-Hind **Condemns Discriminatory Actions**

Seeks Justice for Sambhal Incident, and provides ₹5 Lakh for Families of Police Firing Victims



New Delhi, November 20, 2024:

Ulama-i-Hind President. Maulana Mahmood Asa'd Madani, has expressed grave concern over the recent communal violence in Sambhal, Uttar Pradesh, The unrest followed a court-ordered survey at the historic Jama Masjid, based on claims that the mosque was originally a temple.

Maulana Madani condemned these actions, stressing that such surveys, often rooted in fabricated historical narratives, pose a significant threat to India's secular fabric and disrupt social harmony.

He highlighted the Places of Worship (Special Provisions) Act, of 1991, which protects the religious status of places of worship as they stood on August 15, 1947. He stressed that the growing trend of targeting mosques under these pretexts is undermining national unity, as it allows divisive forces to deepen communal rifts.

"These actions weaken national unity and provide a platform for communal forces to harm social cohesion," Maulana Madani said, urging the judiciary to consider the broader implications of their decisions on national peace.

The situation took a tragic turn on November 24, when three Muslim youths were killed in police firing at the

Masjid. Maulana Madani Jama condemned the police action as "oppressive and discriminatory," holding the Uttar Pradesh government and police administration accountable for the deaths. He emphasized that the Constitution guarantees dignity and protection for all citizens, irrespective of religion, caste, or belief.

"A government that devalues the lives of a particular community violates



the Constitution and the rule of law," Maulana Madani stated.

Maulana Madani also criticized individuals accompanying the survey team, who allegedly raised provocative slogans, further escalating tensions. He questioned why the police permitted such actions and called for immediate action against those responsible, including Vishnu Jain, the lawyer accused of incitement. He expressed disapproval of the local court's decision to authorize the survey without hearing

from the mosque committee and urged higher courts to review the verdict in light of constitutional protections.

In response to the violence, Jamiat Ulama-i-Hind dispatched a delegation led by General Secretary Maulana Hakimuddin Qasmi to Sambhal on November 25. The delegation met with local authorities, including the District Collector and Superintendent of Police, demanding justice for the victims, compensation for their families, and accountability for the police officers involved. They also called for an impartial judicial inquiry and the arrest of those inciting violence. Additionally, the delegation sought compensation of 50 lakhs for each victim's family.

In a letter to the Chief Justice of India on November 26, Maulana Madani called for immediate judicial intervention to stop the misuse of mosque surveys being conducted under divisive agendas. He expressed concern that these surveys are inciting communal discord rather than promoting social harmony, threatening India's secular values. Maulana Madani urged the judiciary to prevent the misuse of such actions and to uphold the spirit of the Places of Worship Act, 1991, to prevent further escalation of tensions and safeguard national unity.

November 28, **Jamiat** Ulama-i-Hind announced financial assistance of 5 lakhs for the families of the deceased and pledged full support for the injured. A relief committee was formed to provide legal and constitutional aid to the victims. Maulana Hakimuddin Qasmi, Jamiat's Secretary, condemned the police's inhumane treatment of the wounded, alleging that detainees were shackled and pressured to alter their statements.

The Jamiat delegation visited victims in the hospital and met with their families, reaffirming their commitment to supporting them in their quest for justice. The leadership pledged to continue fighting for the protection of religious sites, upholding the rights of the oppressed, and standing against communal violence.

This incident has sparked national debate, with growing calls for authorities to prioritize communal harmony and safeguard constitutional values.

## India is Our Birthplace and Place of Karma: Maulana Madani

Farrukhabad, Uttar Pradesh, November 2, 2024:

Maulana Mahmood Madani, President of Jamiat Ulama-i-Hind, emphasized that India is both our birthplace and our place of karma. He stated, "We live here, serve humanity with dedication, and die here. As Muslims, our approach must be engaging, not hostile. Trials and challenges are the marks of a living nation."

Speaking at the Dastarbandi Ceremony and Educational Awareness Conference at Jamia Abu Bakr Siddique, Shamshabad, Maulana Madani underscored the importance of Islamic institutions and the need to balance

Expressing concern about emotional reactions, Maulana Madani urged Muslims to adopt the constructive approach exemplified by Prophet Muhammad (PBUH) and great saints like Khwaja Moinuddin Chishti.

Other scholars, including Mufti Muhammad Rashid Azmi and Maulana Anis Ahmed Azad Bilgrami, enriched the conference with insights into the Qur'an and its memorization. The event was presided over by Maulana Aminul Haq Abdullah Qasmi and co-chaired by Maulana Abdul Rab Qasmi.

# Jamiat President Hails Supreme Court's Landmark Verdict on Bulldozer Justice



New Delhi, 13th November, 2024:

Maulana Mahmood Asa'd Madani, President of Jamiat Ulama-i-Hind, the primary petitioner in case No. 295/2022, welcomed the Supreme Court's decisive ruling against the practice of "bulldozer justice," calling it a significant step towards safeguarding the rule of law and the fundamental rights of citizens. He stated, "This verdict sends a clear message to those who undermine justice. It reminds us that the power to declare someone guilty lies solely with the judiciary, not the administration. The government and its officials, who acted as courts by demolishing people's properties, must understand that such unlawful actions are unacceptable. This ruling is a victory for justice, and we hope it will serve as a lesson to all authorities."

Maulana Madani further emphasized that compensation should be provided to all those whose properties were demolished without proper legal procedures. He added, "The Constitution protects the fundamental rights of every citizen, and any unconstitutional actions that infringe upon those rights must be stopped. Jamaat Ulama-i-Hind has always fought to protect justice and constitutional rights, and this decision strengthens our resolve to continue this fight."

#### Supreme Court's Guidelines on Bulldozer Justice

- A detailed inspection report must be prepared by the relevant authority before any demolition action.
- 2. The demolition process must be recorded via videography.
- 3. The demolition report must include the names of police and civil officers involved in the action.
- 4. The report must be sent to the Municipal Commissioner and made available on a digital portal.

#### In Case of Violations of These Guidelines

- 1. Contempt of court proceedings and legal cases will be initiated.
- 2. Officers responsible for violations will be personally held accountable for the restoration of the demolished property and compensation for damages.
- 3. A directive has been issued to send the judgment to the Chief Secretaries of all states and Union Territories and the Registrars General of all High Courts.
- 4. All state governments have been instructed to issue circulars informing their authorities about the decision.

Maulana Madani also praised the words of Justice B.R. Gavai, who began his verdict with heartfelt lines: ''अपना घर हो, अपना आंगन हो, इस ख्वाब में हर कोई जीता है। इंसान के दिल की ये चाहत है, कि एक घर का सपना कभी न छूटे।'' These words express the universal longing for a home of one's own and the deep desire that this dream should never be shattered. Justice Gavai's statement resonates with the pain of all individuals who have lost their homes due to unlawful actions by the government.

#### The Verdict of the Supreme Court

In a strong condemnation of the "bulldozer justice" practice, the Supreme Court ruled today that neither the government nor the administration can demolish an individual's property solely based on accusations or criminal convictions. The Court made it clear that such actions affect not only the individual's rights but also the rights of their entire household.

The judgment was delivered during the hearing of petition No. 295/2022 filed by Maulana Mahmood Asa'd Madani, President of Jamaat Ulama-i-Hind. The Court also acknowledged the contributions of senior counsel MR Shamshad and others for assisting the Court in formulating guidelines on this matter.

The Court's ruling emphasized that allowing such actions would undermine the rule of law and violate the principle of separation of powers, as determining guilt is the responsibility of the judiciary, not the administration. The Court further stated that demolition based solely on accusations weakens the rule of law and amounts to a violation of constitutional principles. It also highlighted that such actions could be seen as imposing "collective punishment" on the families of those accused or convicted.

Mr Shamshad Advocate Supreme Court, represented Jamiat in the court

The Court also directed that officers involved in demolitions without legal due process should be held accountable, and compensation should be recovered from them if they are found guilty.

harmonious relations similar to those with followers of other religions." He urged scholars to strengthen their spiritual connection with Allah through regular remembrance (zikr) and attachment to a spiritual mentor, emphasizing that this would bring blessings to their endeavours.

 Mufti Muhammad Rashid Azmi: He highlighted that the preservation of Islam and its finality is a divine responsibility and that combating deviations is a duty obligated by the Prophet Muhammad (PBUH). He reiterated that false claimants of prophethood, such as Musailamah Kazzab, were decisively dealt with during the Prophet's era.

- Mufti Salman Mansoorpuri: H e stressed the importance of public awareness campaigns on Khatm-e-Nubuwwat and publishing educational literature. He noted, "Addressing falsehood is essential to uphold the truth. This requires patience, unity, and a commitment to communal harmony."
- Maulana Abdul Qawi: He advised scholars to cultivate continuous learning and maintain close contact with the community, particularly in areas where misinformation is prevalent.
- Mufti Iqbal Qasmi: He called on scholars to adopt a proactive approach to countering deviations by exposing their flawed ideologies in a balanced and constructive manner.

# Supreme Court's Verdict Upholds Legal Status of **UP Madrasa Board**



Jamiat President Maulana Madani Hails the Verdict

n a historic ruling, the Supreme Court of India has overturned the 1967 Aziz Basha v. Union of India judgment, affirming the minority status of Aligarh Muslim University (AMU). The seven-member bench, led by Chief Justice of India D.Y. Chandrachud, declared that an institution's minority character cannot be dismissed solely because it was established by a central act of Parliament, Chief Justice Chandrachud emphasized that Article 30, which guarantees the rights of minorities to establish and administer educational institutions, applies to both pre- and post-Constitution institutions. Furthermore, the Court clarified that for an institution to hold minority status, it

must have been established by a minority community, though it need not be entirely managed

Maulana Mahmood Asa'd Madani, President of Jamiat Ulama-i-Hind, welcomed the Supreme Court's verdict as a significant affirmation of minority rights in India. He stated, "This verdict is a lesson for the current government, which for years, has hindered efforts to restore AMU's minority status."

University in 1981. This convention, attended by delegates from across the country, called on the government to pass an amendment to safeguard AMU's minority status. Parliament responded with the 1981 Act, but lingering biases in the bureaucracy led to discrepancies in the Act, sparking further legal challenges. In 2006, the Allahabad High Court once again nullified AMU's minority status.

#### A Call for the **Promotion of Education**

Maulana Madani reiterated the importance of AMU as a vital legacy for Indian Muslims and called for the university to remain dedicated to its founding mission, particularly in light of the educational challenges facing the Muslim community. "Altering minority status of institutions like AMU not only undermines constitutional protections but also deepens educational disadvantages faced by Muslims," he said.

Maulana Madani commended the determined legal advocacy of AMU, the AMU Old Boys Association, and other intervening organizations. He also urged the Muslim community to prioritize education, calling on the youth to pursue higher studies and contribute meaningfully to the progress of both the country and their community.

This ruling marks a significant step in reinforcing the rights of minority institutions in India and sets a strong precedent for the protection educational institutions founded minority communities.

# Jamiat to Intensify Efforts Against Islamophobia and Hate Crimes

# Juvenile Acquitted in Nuh Violence Case:

New Delhi, 22 November 2024:

n a significant ruling, a juvenile detained in connection with the communal violence in Haryana's Nuh district on July 31, 2023, has been acquitted by the Additional Civil Judge for juvenile cases. The court, in case file No. 8241/2024, concluded that the minor from Bhadas village had no involvement in the violence and could not be held accountable for the alleged crime.

The juvenile had been arrested under FIR No. 142 at Nagina police station during the aftermath of the violence. His legal defense was spearheaded by Advocate Tahir Rupadiya under the guidance of **Jamiat Ulama -i-Hind**, an organization that has been actively rehabilitating affected families, restoring damaged places of worship, and ensuring legal aid for those falsely accused.



# Delhi Court Grants Bail to Mohd. Yunus in Constable Ratan Lal Case After Eight Previous Rejections

#### New Delhi, 24 November 2024:

he Additional Sessions Judge, Shri Pulastya Pramachala, Karkardooma Courts, Delhi, has granted bail to Mohd. Yunus in FIR No. 60/20, PS Dayalpur, a case linked to the February 2020 North-East Delhi riots. This decision comes after eight previous bail applications were rejected, the most recent denial occurring on July 23, 2024.

Advocate Salim Malik, representing the accused, successfully argued for bail on the principle of parity, referencing the recent bail granted by the Delhi High Court to co-accused Mohd. Jalaluddin and Mohd. Wasim on November 4, 2024. Despite the allegations against Yunus, including participation in a riotous mob, conspiracy, and abetment leading to the death of Delhi Police Constable Ratan Lal, the court acknowledged that changed circumstances warranted granting bail.




